## **A- BRIEF DESCRIPTION OF THE WORK FOR WHICH RFP IS SOUGHT FOR.**

Self-financed DAV schools is a fast-growing educational institution in the state of Odisha with existing 60 numbers of schools spanning over the state. New DAV institutions have been planned for their execution at Bhubaneswar, Puri, Angul, Sambalpur and Rourkela. The existing school infrastructures needs modernization and regular maintenance measures.

For timely completion of these projects, applications have been invited through wide circulation for empanelment of qualified and certified contractors for different scope of works towards construction of institution buildings and ancillary works but not limited to Field survey, Architectural design, Geotechnical investigations, Structural design, Civil construction including road, drainage and pavements, Electrical work, Networking (LAN/WAN) and telecommunication, Public Address System, PH and Plumbing, Heating-Ventilation-Air conditioning (HVAC), signage, campus lighting, plantation, interior work and furnishing along with supply of furniture , Acoustics and Sound, repair and maintenance works.

These works are either on turnkey or job work basis.

## **B- VALIDITY OF THE EMPANELMENT.**

The validity of the empanelment is for a period of THREE years only from the date of empanelment. The empanelment validity period may be extended on mutual consent.

## **C- EMPANELMENT PROPOSAL.**

The contractor is requested to submit the empanelment proposal in the form of hard copy on or before the closing date at the place of submission as indicated in the Information Sheet.

## **D- PROCEDURE FOR SUBMISSION.**

The envelope containing the hard copy of the empanelment proposal duly filled in along with processing fee and supporting documents shall be sealed and superscripted as “**EMPANELMENT PROPOSAL**” vide advertisement number 135/2025 date 07.02.2025.

## **E- OPENING OF EMPANELMENT PROPOSAL.**

The opening of the proposal will be done as per the schedule date and time as mentioned in the Information sheet.

## **F- EVALUATION OF THE PROPOSAL.**

A two stage evaluation process will be conducted as explained below for evaluation of the empanelment proposal submitted.

Technical Evaluation (weightage 80%): This will be based on the different types of jobs carried out by the contractor as per the pre-qualification criteria. Credential Evaluation (weightage 20%): This will be based on confidential report submitted by the contractor as per the Format of Confidential report.

## **G-AMENDMENT OF THE RFP DOCUMENT.**

At any time before submission of the proposals, the client may amend the RFP by issuing an addendum through website. Any such addendum will be binding of all applicants. To give the applicants a reasonable time in which to take an addendum into account in preparing their proposals, the client may, at its discretion, extend the dead line for submission of the proposals.

## **H-ACCEPTANCE OF PROPOSAL.**

The client reserves the right to accept or reject any proposal, and to amend the selection process and reject all proposals at any time prior to award of empanelment without assigning any reason there of and thereby incurring any liability to the applicants.

## **I-GENERAL INFORMATION FOR THE CONTRACTORS FOR EMPANELMENT.**

General information for the Contractors seeking empanelment under Regional Directorate, DAV Institutions, Odisha for undertaking various works as listed above.

1. Intending contractors are requested to furnish details about their firm, technical experience, competence and evidence of their financial standing as per enclosed proforma for considering their names for empanelment.
2. Sister concern, subsidiary and/or Joint Venture is NOT ALLOWED.
3. The intending applicant must have registered Firm/Office in the State of Odisha or registered contractors of different class under Govt. norm. Registered address proof shall have to be submitted.
4. Selection of contractors will be based on the ability and competence required for good quality jobs to be performed by them and satisfying the short-listing criteria mentioned in the application form.
5. If the space provided in the proforma is insufficient for giving full details, the same may be given on a separate sheet of paper.
6. Information furnished to the Regional Directorate will be kept as strictly confidential.
7. Decision of the Regional Directorate regarding selection of contractors for empanelment will be final and binding and no further correspondence will be entertained.
8. Contractors who are empaneled by the Regional Directorate after completion of tendering process will be informed by post/ e-mail.
9. Intending contractors are requested to read carefully before filling the particulars in the proforma.
10. The application form should be submitted as per the time schedule mentioned in the application form. The application after expiry of the last date/schedule time will be summarily rejected
11. Incomplete application will not be considered.
12. Information/details furnished by selected party, if found to be false at any time in future or any information affecting empanelment is willingly/unwillingly withheld, if come to the notice of the Regional Directorate at any point of time, the party's empanelment will be cancelled

immediately and will be blacklisted for participation in various tenders floated by the Regional Directorate, DAV Institutions, Odisha.

13. Where copies are required to be furnished, these should be self-certified copies.
14. Application form is not transferable.
15. The solvency certificate should not be older than six calendar months which will be reckoned from the date of release of advertisement of empanelment.
16. Empanelment of the firm/Contractors will be valid only for THREE years from the date of empanelment.
17. The contractors already on empaneled list of Regional Directorate shall submit fresh application along with application fee and necessary documents required to consider their application for fresh empanelment in the same category/upgrading of their name in the category.
18. The selection of the participating contractors will be based on the satisfying the short-listing criteria as mentioned in the application form and past performance of the works in the DAV Institutions.
19. One Contractor shall submit one application only. Multiple applications shall liable to cancellation of all applications submitted by the concerned contractor forfeiting the application fee.
20. If empaneled, the contractors shall only entitle him/her to be considered for participation in subsequent tendering process as and when necessary subject to the conditions laid down in each individual Notice inviting tenders. It shall not confer any right on him either to be necessarily qualified in the tender process or qualify for award of works.
21. Subsequent to the empanelment, if any of the contractor found dismissed /blacklisted from any of the DAV Institutions/other firms, the said agency / firm will be immediately dismissed/blacklisted from the panel of the Regional Directorate.


